B	Default category for most business models. It includes websites that accept refills, transfers, or new prescriptions; telemedicine services; hospitals; pharmaceutical manufacturers; or pharmacies that fill via mail-order or some other form of remote ordering service.	\$745	\$1,495
C	Complex business models that take more time or expertise to review, such as sterile compounding, nuclear pharmacy, or online veterinary pharmacies.	\$995	\$1,995

Pricing is based on the level of complexity in reviewing and monitoring your operation. Within each price range, prices vary depending on the number of jurisdictions in which you are licensed, domiciled, or serve cardholders. The application fee is non-refundable.
