### In your experience, why is human review so important for effective merchant monitoring?

Human review is the backbone of our merchant monitoring program. Our goal is to provide our clients with clear, concise, and 100% accurate risk analysis. In order to deliver that, we use technology to run initial automated checks on our monitored pool, but an analyst must always manually review anything that was triggered by the system before the analysis gets communicated to the client. By doing so, we avoid not only over-flagging false positives but also erroneous assessments.

#### What differentiates LegitScript from other solutions?

LegitScript's mission, for sure, and the incredibly smart and dedicated people I get to work with. Knowing that the monitoring we do every day matters and is making a real difference is the most gratifying part of my work. Plus, I have never had a boring day (which is still true after three and half years!). There is always something new to learn.
