The US Food and Drug Administration (FDA) and Federal Trade Commission (FTC) take misleading medical claims seriously. Banks, payment service providers, and internet platforms face regulatory risk not only if products are intrinsically violative but also if merchants are found to make misleading claims. That's why LegitScript tracks whether products are illegal (classified as "Red Flag") or are associated with misleading claims (classified as "Yellow Flag").

#### Red Flag

Products are tainted or dangerous, contain unapproved drugs, or are sold in some intrinsically problematic manner.

Yellow Flag

Products are sometimes marketed with impermissible claims that they can cure, mitigate, treat, or prevent diseases, or they contain unsubstantiated claims that they affect the structure or function of the body.
